28-Day Review Updated Rule 3.5

Fences, Walls and Hedges.

Windbreaks and sound screens will be treated like fences. No fence, wall or hedge may exceed six feet in height, subject to any requirement of the City of Oceanside which is more restrictive.... Fencing or walls maintained by the Master Association may not be modified without the express written approval of the Board. Fencing originally constructed on a lot by the builder may not be altered or removed without the express written approval of the ARC or Board; except that an alteration defined as a "Pre- Approved Improvement" in Attachment 1 hereto shall not require ARC approval, but still need a Pre-Approved Application filed prior to the start of the replacement.

Please use the dog waste station trash can or personal trash cans for pet waste bags. Playground trash cans and tot lots are not to be used for pet waste. Additionally, all pets are not allowed in any tot lots and playgrounds for any reason.

Standing Water Concerns

Please be aware of standing water. It can become a breeding ground for harmful bacteria and mosquitoes.

Did you know Homeowners can now submit Home Improvement Applications through our online portal? To submit an application for your proposed home improvement project, login to your account by going to https://www.myrdo.com/my-account.html and clicking the "Log on" icon. After logging into your account click "My Items", then "Submit a Request", then "ARC Request". On the ARC request page be sure to complete the PDF application and then you are all set to submit the form for review. After submission of the application expect a response regarding application completeness via email within 2-4 business days. Submit Early, approvals may take up to 4 weeks.
