## NOTICE OF ARC ELECTION, VILLAGE V

RE: Village V Architectural Review Committee (ARC) Election

### **MEETING PURPOSE:**

Due to a lack of quorum, the meeting of the Village V Members of The Villages of Rancho Del Oro Homeowners Association will reconvene on **Thursday, March 28, 2024 at 2:00 PM**, at the onsite management office. The purpose of this meeting is to elect five (5) Members to the Village V ARC, and to conduct any other business which may come before the Village V Members.

#### **VOTING SUMMARY:**

Voting procedures are provided in detail in your Village V Supplementary Declaration of Conditions, Covenants and Restrictions (CC&Rs), Articles V and VI. Please be aware of the following:

- 1. <u>Notice of Voting Rights.</u> The person(s) entitled to receive notice and vote at the March 19<sup>th</sup> meeting is/are the owner(s) of each lot within Village V as of thirty (30) days prior to the date of the meeting (March 19<sup>th</sup>). Each lot is entitled to one (1) vote for each open ARC position. Therefore, in this election, each lot is allotted five (5) total votes. These votes must be cast by agreement of all owners of the lot.
- 2. <u>Cumulative Voting</u>. You may cumulate your lot's five (5) total votes, and cast all votes for a single nominee, or you may cast any portion of the five (5) votes between the nominees, at your discretion. Fractional voting is not permitted.
- 3. Quorum. At least 25% of the 414 lots in Village V (i.e., 104 lots) must submit a ballot to constitute a quorum. Without a quorum, no business may be conducted, and the meeting must be rescheduled at substantial cost to the Association.

PLEASE RETURN YOUR BALLOT BY MARCH 27, 2024, EVEN IF YOU DO NOT VOTE.
